We recognize that the School reserves the right to dismiss any student whose conduct is deemed by the School Administration to be detrimental to the learning environment and reputation of the School, or whose personal conduct or whose parent/guardian's conduct at any time or place interferes with the school program or brings discredit to the School. We understand that the basis for dismissal can include, but is not limited to, serious or repeated failures of the student to meet academic or behavioral expectations. The School reserves the right to review class openings based on minimum class size requirements.

In the event a student is dismissed or withdrawn, it is agreed the School shall not be liable for claims or for any costs or expenses incurred as a result thereof, and there will be **no reduction of the financial obligation to pay the full year's tuition.**

In view of this obligation, we understand that the Tuition Refund Plan (TRP) is being made available to us at this time to protect our annual financial obligation under the terms of this Enrollment Contract, according to the terms of the policy. TRP is required if tuition is paid by installments. TRP is optional if tuition is paid up front. TRP will insure a portion of tuition (prepaid and due) in the event of student absence or separation according to the terms of the policy. Additionally, the undersigned Parent/Guardian authorize the School to process and collect any claim payments entitled under the TRP. However, the School shall have no obligation to make any claim to TRP and the School's failure to do so will not reduce or eliminate the Parents'/Guardian's liability under this contract. We also agree to pay the School within 30 days after receipt of a final bill whatever balance remains unpaid after any payment made by TRP is credited to the Student's account.

We hereby authorize St. Luke's Lutheran School to utilize our child's photographic image in marketing and advertising efforts of the school, including but not limited to, newspaper and other advertisements, brochures delivered to the public, and the St. Luke's Lutheran School website, and hereby do release, acquit, waive and discharge St. Luke's Lutheran School, its agents, employees and representatives, from any and all costs, liabilities or claims arising from the aforesaid use.
